

## 5-3-16 CBA Criminal Law Executive Committee Meeting minutes

Meeting called to order at 5:45.

Minutes approved.

Treasurer's report: an embarrassment of riches.

April CLE: we had 59 live and 19 on the web for a total of 78 which was higher than in the past. It was a lively presentation. Charley was the consummate moderator and all the presenters did wonderfully. The involvement of actual jurors was successful, in both theory and practice. Some questioned the utility of involving law professors; others found it helpful.

Fall CLE: topic is juvenile justice. Spring of next year's topic is still TBD. The Fall CLE planning is well underway and although we'll miss Janet's involvement, we'll soldier on.

Update on lunchtime meetings: in Adams County, this is on the back burner until things get firmed up with respect to the bench in Adams to see who the new criminal judge is. In Boulder, there will be a lunchtime presentation on CRE 404(b), according to Ken Kupfner. We agree to send out that date to everyone, including non-CBA members. Judge Bernard will send the date out for widespread distribution. Lindy moves that we approve money for food for the Boulder CLE up to \$12 per person, if requested. That motion is approved.

The last time we met, we talked about discounting the DUI CLE being presented by Jay Tiftickian. With regard to discounting the program for members, there is not currently an agenda with confirmed speakers, but once there is one completed, Amy can furnish it to us

for our decision on this and we can make a decision about this in the fall and then the discount (if any) will be reflected on the registration page. The motion to approve this passes unanimously.

With regard to underwriting tuition for our fall update on juvenile law, we discuss whether this is an either/or on scholarships or a yes/and. We also discuss how much is too much on price. The general sense is that \$100 per person may be about right. We are about to receive approximately \$10,000 in dues. People feel that juvenile law is a good place to spend money right now.

The Tom Hammond happy hour will run us \$200-\$300 for food and drinks, by his estimate. It is set for May 26, 2016 from 5:30-7:00 at the Mockery Brewery and he seeks a judge to moderate and prosecutors and defense attorneys to talk briefly about their career paths and answer any questions that may arise. Both Judges Bernard and Hoffman have conflicts but Judge Voles is available as a back-up. Lindy can be there (knowing that Tom will also be there) and Zeke and Tom can be there to fill the prosecutorial role.

We take a moment to reflect on Janet Drake's contributions to the group. CLE will be sending her a note.

Changing of the guard: Ted Tow will be the chair of the committee next year; Ann Roan will be the vice chair; Zeke will become the secretary.

Next meeting will be September 6, 2016, which is the day after Labor Day. We agree to keep it on that day.
