Summary of 01/16/24 CBA Real Estate Section Council Meeting

DATE: 01/16/24

I attended the CBA Real Estate Section Council ("RESC") meeting on 01/16/24 by Zoom. The following is my report on matters addressed which the CBA Trust and Estate Section Council ("TESC") might find of interest:

#1) I encouraged the RESC to attend the CBA CLE Luncheon on "Selling Decedent's Home" sponsored by the T&E Section. It will be on February 6, 2024 and presented by Angela Schmitz. This type of transaction nicely blends both areas of law. The plan is for a notice of this CLE to be sent out to all Real Estate Section members in the coming days. Hopefully, there will be a large turnout.

#2) The Colorado legislature is now in session. Regarding real estate, there is already a new landlord/tenant bill to regulate the practice of using algorithms for setting rents - potential violations of unfair trade and anti-trust laws. Also, there are new HOA bills and affordable housing bills, as well as a treasurer's deed bill. The deed bill is in response to the 2023 U.S. Supreme Court's decision on the unconstitutionality ("takings") of certain types of treasurer's auctions.

#3) Adam Hirsch will be serving as a new member of the Title Standards Committee. He will bring a bankruptcy perspective to the group.


