### General

The Lawyers' Announcements section is reserved to announce the following:

- Relocation of a law practice

- Retirement of attorneys
- Notices of professional appointment, honors, or awards

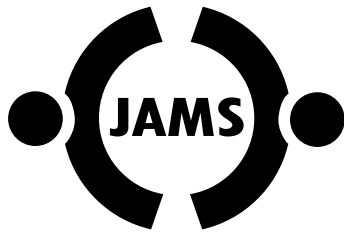
