Lawyers and law firms from across the state raised over \$2 million in the Legal Aid Foundation's annual fundraising drive for Colorado Legal Services. The funds will be used to provide necessary legal assistance in serious civil matters for Coloradans who cannot afford counsel.

The ongoing success of the Legal Aid Foundation's annual campaign is a direct result of the enduring commitment of the Colorado legal community to improving access to the civil justice system. This year, law firm giving accounted for 61% of the total amount raised, with 123 donor firms giving at the Leadership Level of \$450 per Colorado lawyer in the firm. Donations from individual lawyers also reached a record level.

Colorado Legal Services provides legal representation and advice through a network of 13 offices around the state, as well as easy-to-understand, online self-help information and state-of-the-art interactive forms for use in civil proceedings.
