**Sponsor Agreement – 2009 Steamboat CLE Conference**

**Terms:**

1. CBA/CLE will arrange for a 6 foot skirted table and one chair to be used by each Sponsor. **All display items/information must fit within the top of a 6 foot table.** The table shall be set up in a manner so as to provide optimal visibility to registrants and minimal disruption of the educational atmosphere. CBA-CLE shall have discretion as to specific location of tables.
2. Sponsor must set-up on first day of the Conference and break-down on last day of the Conference by the times requested by CBA/CLE.
3. Nothing in this Agreement shall prevent CBA/CLE from seeking sponsorships from any other entity for any Conference.
4. Sponsor agrees to be responsible for any incidental charges that it may accrue at Sponsor table, including, without limitation, any electrical access, phone line or internet hook-up to Sponsor's table, and/or any audiovisual equipment ordered for the Sponsor table. **Sponsor will order this equipment directly from the Conference facility.**
5. On the occasion that CBA/CLE must cancel a scheduled Conference; the Sponsor may receive a refund of payments made to CBA/CLE or a credit to sponsor another CBA/CLE event. CBA/CLE will have no further liability to Sponsor for such cancellation.
6. This Agreement does not constitute an endorsement by CBA/CLE of Sponsor or its products or services; nor may Sponsor represent in any manner that its goods or services have been endorsed by CBA/CLE.
7. Sponsor shall indemnify and hold harmless CBA/CLE, its agents and its employees, from any claims, losses or damages to any person or entity arising or alleged to have arisen out of any acts of Sponsor or its agents in the performance or breach of this Agreement.
