Terms:

1. CBA/CLE will arrange for a 6 foot skirted table and one chair to be used by each Sponsor. **All display items/information must fit within the top of a 6 foot table.** The table shall be set up in a manner so as to provide optimal visibility to registrants and minimal disruption of the educational atmosphere. 7.
