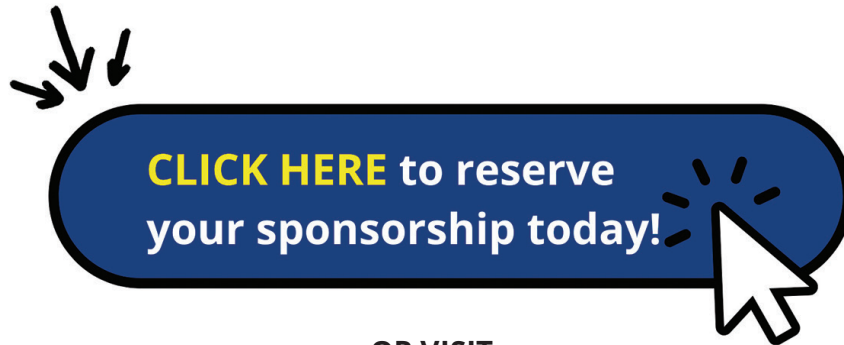

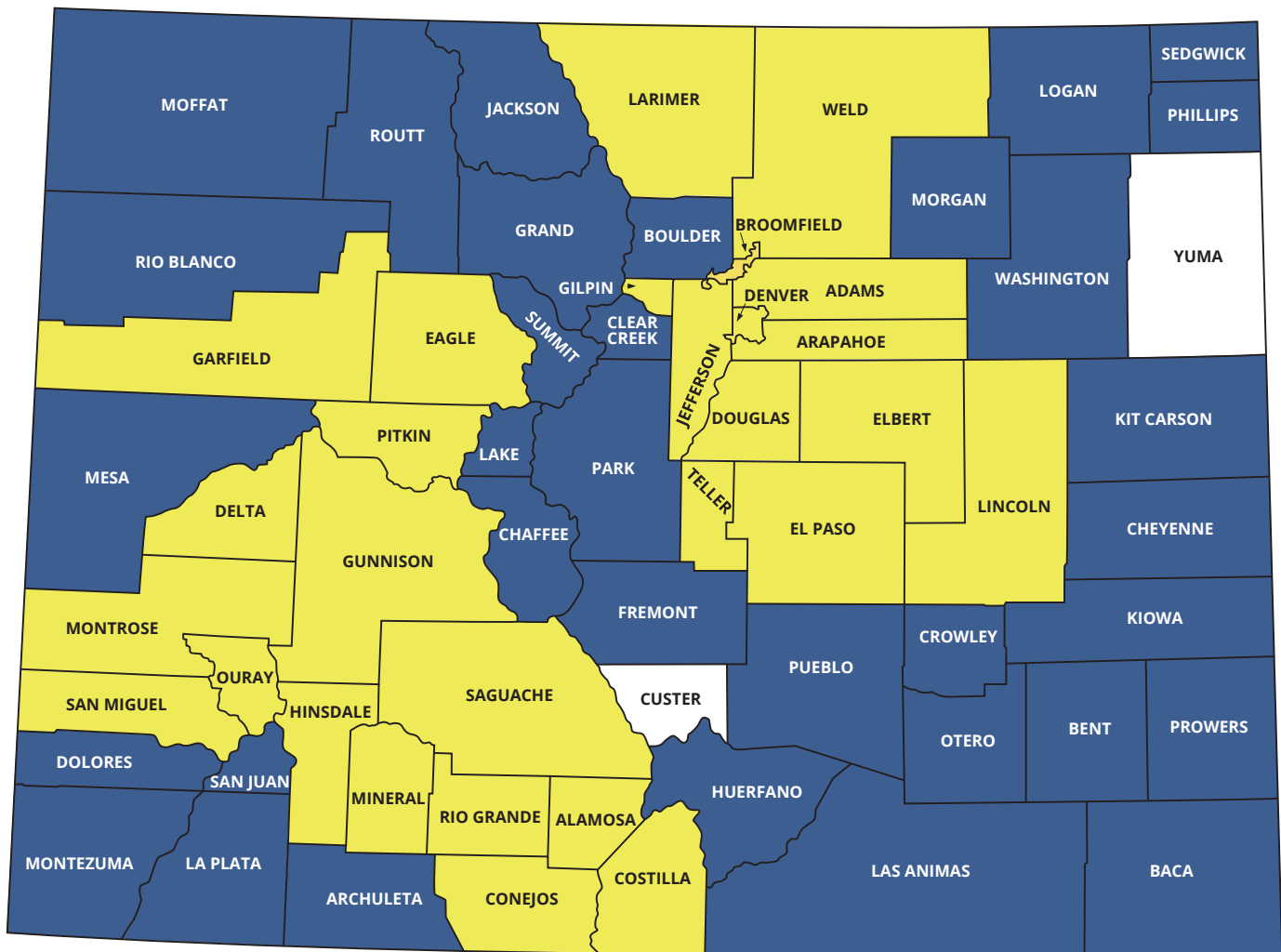

# SPRING EVENT: BLUES ON THE BAYOU FUNDRAISER

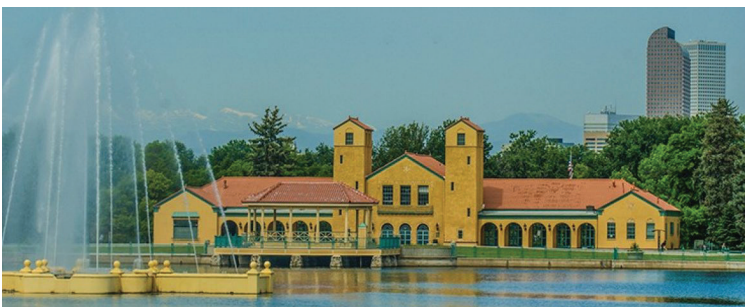
## About the Event
