How can the LITC help me?

- The LITC can represent you before the IRS or in court on audits, appeals, tax collection matters, and other tax disputes. Services are provided for free or for a small fee.
- Although the LITC receives partial funding from the IRS, LITCs, its employees, and its volunteers are completely independent of the IRS.
- In order to qualify for assistance from an LITC, generally a taxpayer's income must be below a certain threshold, and the amount in dispute with the IRS is usually less than \$50,000.

For instance, if you filed a tax return and claimed certain deductions or credits (such as the EITC), and the IRS has not paid you your refund, contact us to see if we can help.
