The Lawyers' Announcements section is reserved to announce the following:

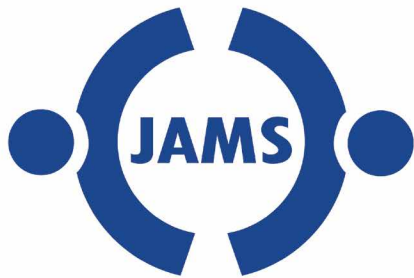

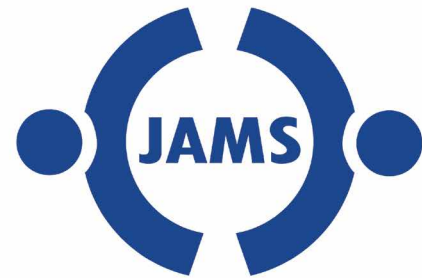
