Council met on Wednesday, November 2, 2022 via audio-conference. The meeting was called to order at approximately 3:18 p.m. by Molly Zwerdlinger, Chair.

1. Review/approval of October 6, 2022 Minutes.

The draft of the October 6, 2022 minutes were approved unanimously.

2. Succession Items re: Council Member Vacancy, Committee Chair, Liaisons and Representatives

a. Vacancy- Executive Council First Year Member.

Dylan Metzner motioned to form Nominating Committee, to consist of Chair (Molly Zwerdlinger); Vice Chair (Lauren da Cunha); Secretary/Treasurer (Dylan Metzner) and Immediate Past Chair (Tim Bounds) and the Nominating Committee to be charged with reviewing applications and making recommendations to Council for a vote at the December meeting to select the applicant to fill the vacancy of First Year Council Membership.

Motion duly seconded and passed unanimously.

- **b.** Succession Planning- Legislative Liaison. No discussion.
- c. Discussion- re Possible Creation of Liaison to ADR Section No discussion.
- 3. Chair's Report and Administrative Matters (Molly Zwerdlinger)

Discussed either Certificates or plaques for chairs and Executive Council members. Certificates will be issued for all Committee Chairs and plaques will be issued to Executive Council Members and Officers when they term out (or in the case of officers, an officer's last year of consecutive service as an Officer).

4. Secretary/Treasurer's report (Dylan Metzner)

Secretary/Treasurer reported that financials are in good shape and the September 30th balance of \$68,726 is higher than last year's September 30th balance of \$65,535.

Based discussion during October's Executive Council's meeting, Secretary/Treasurer will review the financials from previous years to make a report back to Council as to balances over the past for purposes of potentially establishing setting a minimum amount to keep in the account for unexpected expenses or dips in revenue. Goal is for the report to Council to occur at either the December or the January meeting.

The Sterling Ambler Dinner will occur this evening and we are expecting approximately36 attendees.

5. Tax Section Liaison (Aaron Burton) No report.

6. Elder Law Section (Patrick Thiessen)

Sandra Siegler and Kayla Nelson Reported- Elder law retreat will be in Vail at the end of august. A couple of pieces in the Medicaid committee that will be brought up in general discussion due to trouble that is being had with income cap trusts created by a agents

acting pursuant to durable power of attorney. Elder Law is working on possible statutory changes to allow agents to create these trusts.

7. Real Estate Section Liaison (Chad Rounds)

Amendment D CBA is supporting.

The Section discussed a District Court case against law firm for unfair debt collection and the question is whether the law firm is a debt collector under the act as well as Denver Ordinance 305 which is part of Denver's 2022 Ballot.

8. Family Law Section Liaison (Kim Willoughby) No report.

9. Statutory Revisions Committee (Jonathan Haskell)

SRC approved proposed amendment to definition of "Interested Person". Current definition of "Interested Person" in CUTC is constrained by the definition of Qualified Beneficiary. With this constraint the concern, which came from a real world case, is that if a trust amendment removed a beneficiary and that removed beneficiary has concerns about the trust settlor's capacity to execute the amendment then the removed beneficiary is no longer an Interested Person under CUTC. If this happened in a will the removed beneficiary would have standing. The language approved by SRC, without much discussion an no objections, is as follows:

(10) "Interested person" means a qualified beneficiary or other person having a property right in or claim against a trust estate, which right or claim may reasonably and materially be affected by a judicial proceeding pursuant to this code. The term also includes fiduciaries and other persons having authority to act under the terms of the trust. The meaning as it relates to particular persons may vary from time to time and is determined according to the particular purposes of, and matter involved in, any proceeding.

Upon motion duly made and seconded, executive council voted unanimously to approve the language that SRC approved.

In addition, during the SRC meeting Steve Brainard mentioned that the disclosure of fiduciary fees 15-10-602 and 15-12-705 was passed by SRC and Council back in 2015-2016 but it never was passed by LPC. Dylan Metzner and Jonathan Haskell will review this and discuss at the December or January Council Meeting.

10. Legislative Liaison (Steve Brainerd) No Report.

11. Legislative Update (Tyler Mounsey)

CBA is supporting Amendment D which is part of Colorado's 2022 Ballot.

Not much to report at this point due to the General Assembly's focus on the upcoming election. Tyler encourages communications with him if there are any items that the Section think may be appropriate to bring to the legislature.

Colorado General Assembly SRC is looking for two new non legislative attorneys. If you are interested please reach out to Tyler.

This year is going to be a fiscally lien year.

CBA is supporting Amendment D.

12. Council Notes (Kristin Dittus)

Usual publications for next Council Notes and Kristin will do an article on credit card processing fee that can get passed along to clients.

13. CLE/Estate Planning Retreat (Lauren da Cunha)

Great response to RFP for presenters. Committee planned all of the sessions for the retreat with some follow up work for specific presenters. One more lunch to plan for 2022-2023.

Retreat is in Santa Fe June 8-10th.

14. Orange Book Forms Committee (Rikke Liska)

Still working on beneficiary deed form. Also looking at issue that Elder Law has been talking about regarding changes to "hot power" language in the POA to address the income trust powers for Medicaid purposes.

15. Supreme Court's Rules and Forms Committee (Leia Ursury)

Cleanup issues are getting finalized by the Committee. There is a question regarding the new supportive decision making agreement specifically as to whether if the forms are updated to ask for disclosure of other individuals (such as a request for beneficiaries listed in a beneficiary designation agreement) such updates would open the door for a requirement to provide notice to individuals who do not need notice.

Discussion as to whether fiduciary appointment forms that include disclosure of fees opens the door to arguments that those disclosed fees are approved if the fiduciary is appointed. The Committee is not clear as to whether this is truly an issue that needs to be addressed in the form.

If anyone has a substantive issue with a Form please contact Leia and she will bring that issue to the attention of the Committee.

16. Civic and Community Affairs Joint Committee of the Elder Law Section (Sandra Sigler) Senior Law Handbook Time. Requesting for Section support this year. Along with everything else printing costs have increased. Increase annual ask from \$2,500 to \$3,000. Hoping to be printing pre-covid level number of books (approximately 5,000 in fees).

Motion duly made and seconded was approved Unanimously. Section will contribute \$3,000 to Committee for Handbook.

Still planning on having a number of events in 2023 in various countries.

Advanced Medical Directive Brochure is finalized and Civic and Community Affairs Joint Committee will be asked for approval by Council at December's meeting.

17. Justice Equity Diversity and Inclusivity (formerly known as the Equity, Diversity, and Inclusivity)Committee (Amber Marchlowska)

LGTBQ Gala table was a success all seats were filled. Committee has another \$500 left in budget for next year's galas and will also begin internal fundraising.

Committee voted to be renamed the Justice Equity Diversity and Inclusivity (JEDI) Committee

DU Sturm is doing CLE series on EDI topics. Amber will reach out to Elder Law to see if JEDI can be made a joint committee.

I attended the CBA Real Estate Section Council ("RESC") meeting on 11/15/22 by Zoom. The following is my report on matters addressed which the CBA Trust and Estate Section Council ("TESC") might find of interest:

Tyler Mounsey gave the RESC a recap of the effect of the November election on Colorado's 2023 state legislature.

Federal targeting orders have been issued during the last 3 to 4 years in an attempt to combat criminal financial transactions. Title companies in the targeted areas are required to report to the Federal government residential real estate transactions purchased with a certain amount of cash. None of these orders currently cover Colorado.

A realty company has tried to increase listings throughout the country by giving "free" money to potential sellers of real estate in exchange for a promise to list with the company within forty years. The company files liens on the subject properties to protect its interests. The Colorado Association of Realtors plans to run a state bill to stop this practice in Colorado. In general, medical professionals will attempt to locate as many interested persons as practicable. Often this includes parents, children, grandchildren, and close friends.

In order for a proxy decision maker to have authority to make medical decisions, the patient's attending physician must determine that the patient lacks the ability to provide informed consent to or refusal of medical treatment. Medical professionals must try to tell the patient that he or she lacks the ability to provide informed consent and that a close relative or friend will be selected to make medical decisions for them.

Frequently Asked Questions

Where should I store my advance directives? You should keep the directives somewhere that is easily accessible and you should inform your loved ones where to find them. It is not a good idea to place the documents in a safe deposit box at a bank, as on weekends, holidays, and nights, the documents would not be available for use.

Should I talk with my family

and friends about my documents?

Yes. When it comes to end of life and medical treatment issues, communication with family members and close friends is the key to ensuring your wishes are followed. Take the time to discuss these issues with your family, close friends, and medical professionals so that they understand your values. The documents do not cover every possible scenario.

How do I convey my values in my advance directives? Your advance medical directive(s) should include statements about your values and any religious beliefs that would either prohibit or require certain types of medical care. How do I inform my doctors and other medical professionals about my documents? You should provide either a physical or an electronic copy of your documents to your primary care doctors and specialists. Take the documents along to your next visit or upload the documents to the medical records portal used by your health care providers.

I just moved to a different state.

Are my advance directives still valid?

If your advance medical directives comply with the state law where the directive were executed, they will likely be recognized and honored in all other states. If you have any questions about whether the directives are valid, consult an attorney.

What if I spend part of the year in another state?

If you spend a significant amount of time in more than one state, such as having a vacation or winter home in another state, you should execute documents in both states in case there are different requirements. It is very important to make sure all your declarations are consistent to avoid any confusion or disputes.

What do I do if I change or revoke my advance directives?

If you revoke or amend any of your advance directives, it is very important that you provide your doctor, family, and anyone else with the most current versions so they are aware of your wishes.

Advance Medical Directives

Every adult has the legal right to consent to or refuse medical treatment. Advance medical directives are legal documents that state your wishes about your medical care when you are not able to communicate yourself.

In Colorado there are two common advance medical directives:

- A Medical/Health Care Power of Attorney
- A Declaration as to Medical or Surgical Treatment (sometimes called a "living will")

An advance medical directive does not take away your right to make medical decisions if you are able to do so. It allows your beliefs and decisions to be carried out even when you cannot communicate them.

If you become incapacitated and you do not have any advance medical directives, your loved ones may have to go to court and pursue a guardianship to have the authority to make medical decisions for you.

While you are encouraged to work with an attorney to execute advance medical directives, forms are available at most office supply stores or by searching the internet. If you choose to use a form, make sure it is a Colorado form as the requirements for advance medical directives are specific to each state.

Medical Durable Power of Attorney

A Medical Durable Power of Attorney identifies the person who will make medical decisions for you when you cannot make them for yourself. This person is known as the "agent," and they can make any medical decisions you could make for yourself, if you were able to do so.

Your medical power of attorney may grant your agent very broad authority or limit their authority. The document may include directions and guidance as to your wishes and beliefs. You may name alternate or successor agents. A medical power of attorney can be revoked at any time.

A medical power of attorney should include a statement giving medical professionals permission to release information to your agent even before it is determined you cannot make decisions for yourself. This provision allows the agent to communicate with the medical professionals to determine whether you are incapacitated.

Declaration as to Medical or Surgical Treatment

In Colorado, individuals may execute a "Declaration as to Medical or Surgical Treatment," sometimes referred to as a "Living Will." This Declaration covers the type of life-sustaining procedures you want when you have a terminal condition or are in a persistent vegetative state. In these very limited circumstances, statements you make in a properly executed Declaration as to Medical or Surgical Treatment govern your treating physician's course of action regarding artificial nutrition, artificial hydration, and the administration, removal, or refusal of life- sustaining procedures.

Under Colorado law, a "life-sustaining procedure" is any medical procedure that only serves to prolong the dying process, including CPR, defibrillation, medications, and surgery.

A Declaration as to Medical or Surgical Treatment may also include declarations regarding your wishes as to your treatment if you are in a persistent vegetative state.

Regardless of your decision to accept or reject lifesustaining treatment, medical professionals will continue to provide all necessary treatment to alleviate pain and suffering.

A Declaration as to Medical or Surgical Treatment may be revoked or amended at any time.

Other common documents and situations *CPR Orders/Do not Resuscitate Orders*

CPR treatments are medical procedures that attempt to restore cardiac function or support breathing, including chest compressions, electric shocks, and breathing tubes. You must get a CPR directive from your doctor's office or the Colorado Department of Health, and your doctor must sign it after a consultation. If you have a CPR directive, you should place it prominently in your home (on the front door or refrigerator) so that emergency medical personnel can find it easily and carry out your wishes. In addition, you may receive an id bracelet, that indicates you do not want CPR administered.

Disposition of Last Remains Declarations

You have the right and power to direct the disposition of your last remains. Colorado laws provides protection from individuals who may try to impose their views over your stated wishes.

The declaration may cover disposition (cremation, burial, entombment) and ceremonial instructions, and must be signed and dated by you. If you do not make a declaration, your Personal Representative, spouse, designated beneficiary, adult children, parents, guardian, conservator, majority of adult siblings, can make the decision for you. If none of the above individuals are available, then any person willing to pay gets to decide for you.

Organ and Tissue Donation Declarations

You may make a declaration regarding organ and tissue donation in a stand-alone document, Declaration as to Medical or Surgical Treatment, or on your driver's license. You may give specific direction as to who should benefit from the donation and may even give certain individuals, such as family members a preference. If you do not make a declaration, your agent, spouse, adult children, parents, adult siblings, adult grandchildren, grandparents, caregiver, or your guardian, if applicable gets to decide to make an organ and/or tissue donation.

Proxy Decision Maker for Medical Treatment

If you do not make any advance medical directives, Colorado law allows heath care providers to rely on a proxy decision maker chosen by "interested persons" to make decisions for an incapacitated patient.

While completing a judicial externship is a part of this program, this program is much more than a typical judicial externship.

I am writing to you in support of the Greater Colorado Law Student Experience and their grant application for funding for the summer of 2023.

When Judge Shamis and Sumi Lee approached our Career Development Office about the Greater Colorado Law Student Experience for the summer of 2022, we listened eagerly. As the summer's plans unfolded and they shared their enthusiasm for growing a scalable program that would expose law students to practicing outside of the Denver/Boulder area and that would help to serve the communities in which they would spend their summer, we were eager to make the program available to our students.

We are aware of the "legal deserts" growing in Greater Colorado and rural areas of many states. Unfortunately, as employment opportunities on the Front Range have remained strong over the last several years, it has become more difficult to attract recent graduates to opportunities available in Greater Colorado. Over the last three years, 90% of our graduates who have remained in Colorado have remained in the Denver metro area.

The Greater Colorado Law Student Experience allows 1L and 2L law students an opportunity to experience what living and working in Greater Colorado entails. The summer experience allows them to build networks outside the Front Range, to serve those communities, and to envision themselves as part of those communities.

The program cannot grow without financial support. Efforts to attract students and graduates to Greater Colorado are impacted by the opportunities available on the Front Range and the challenging housing markets found in many parts of Greater Colorado. Grant funding through the Colorado Bar Foundation can provide participating students with funding for housing and other living expenses while spending time in these communities.



Please consider this a letter of support for a grant application regarding the Greater Colorado Law Student Experience submitted to the Colorado Bar Foundation by Sumi Lee, Head of Judicial Diversity Outreach in the State Court Administrator's Office of the Colorado Judicial Department.

At Denver Law, we are delighted about the possible expansion of this program, which involves both adding additional rural districts to host students and increasing the number of students who can participate in the program. This program has been a value add to Denver Law's rich and robust experiential learning options in summer 2022. I serve as the externship director and annually, we host between 230 and 275 students to work for credit over the summer semester. The number of students within this group who choose to work for credit in rural Colorado, however, is incredibly small. The reality is that students need incentives and intentional efforts to think about opportunities beyond metro Denver. Students are often overwhelmed with the law school curriculum and inundated with employers who are located geographically close to the school. Without intentional engagement, it is far easier for students to select experiential learning options that are the easiest to access and/or that they identify later in the cycle, once they are able to manage their schooling more effectively. With that said, many students want judicial experiences and recognize the value of developing meaningful relationships with members of a courthouse and the region. The Greater Colorado Law Student Experience program packages summer experiential learning so easily for students, creating an ideal setting for them to not just engage with a judge but also understand the broader implications of the legal system, become exposed to practicing in a rural area, and recognize the access to justice needs in such a region.

The stipend for participating in the program is crucial. It offers a critical incentive. Far more offices are paying their externs now. Rather than 20 percent of externships being paid, recent semesters show over 35 percent of students are paid, primarily in the private sector. While it is positive to see increased numbers of students receiving pay, given how frequently students struggle with significant debt, it becomes more difficult for students to select an unpaid option, let alone an unpaid option that might require financing new housing, paying double rents, and/or increased costs associated with travel and commuting. While Denver Law offers stipends to

approximately 50 students per summer for unpaid externships, including the students involved with this program, our stipend fund is still competitive and not every applicant receives funding. We, however, are willing to guarantee a stipend to the students in this program, but it is still not enough given the extraordinary costs. While the combined stipends do not compete financially with many of the weekly or hourly stipends offered to externships, they still serve as additional motivations for students to seek out such a unique and innovative learning opportunity.

Finally, our data shows that externships and post graduate employment are strongly related. Students who complete externships are more likely to be employed upon graduation, contributing to our legal community right away. Further, typically at least 30 percent of students work upon graduation at a former externship site. Far more have indirect connections. For example, many work at placements identified through relationships established during their externships. If students can make connections now, early in their legal careers, in a particular region and/or with particular lawyers, I believe they will be more likely to contribute to the community, care about related access to justice causes, and lawyer with a deeper compassion and understanding of serving "the rural client."

I urge you to fund the program fully. We will continue to partner with the program as it expands. As you navigate your decision-making process, please do not hesitate to contact me with any questions or concerns.

Dear Elizabeth Akalin and the Colorado Bar Foundation Trustees,

We are writing in support of the Greater Colorado Law Student Experience (GCLSE). We are a group of dedicated legal professionals in Pueblo who very much hope to be able to bring the GCLSE program to Pueblo County next year.

Colorado, like much of the nation, is facing a significant issue with providing legal services to citizens in rural and underserved areas. The primary driver of this is the lack of attorneys taking up the opportunity to practice outside well-served major urban areas. This problem, commonly referred to as legal deserts, will require a multi-faceted approach to resolve.

The GCLSE is an exciting new program that can greatly increase attorney recruitment in Greater Colorado. This program works with Colorado's law schools to recruit law students to complete an eight-week externship program in a judicial district outside of the Denver Metro area. Students in the program are afforded the opportunity to live and work in diverse and underserved communities that otherwise likely could not support a robust externship program. It is vital to the GCLSE that students are provided funding for temporary housing and living expenses associated with the externship. By providing a stipend to cover living expenses for the eight-week program, we can remove a major barrier to students exploring the opportunities in Greater Colorado. It is for that reason that we are asking the Colorado Bar Foundation for your support.

Pueblo County is certainly an underserved community. Our local legal community has just 1 attorney for every 1136 citizens in the county (by comparison Denver County has 1 attorney for every 101 citizens). Our local legal community simply does not have the number of attorneys that are necessary to meet the needs of our citizenry. It is abundantly clear that without concerted action this problem is only going to get worse. For that reason, the GCLSE – Pueblo Working Group was formed. We have already secured commitments from Colorado State University Pueblo (housing), the 10th Judicial District (externships), and Colorado Legal Services (community service). Our group is committed and will work diligently to provide law students with an excellent experience and to expose them to all the benefits that come from living and working in the Pueblo area. Having the financial backing of the Colorado Bar Foundation would be a major boon for this program and would ensure that we can draw applicants from all backgrounds and circumstances.

We are writing in support of the Greater Colorado Law Student Experience (GCLSE). We are a group of attorneys and judicial officers working towards establishing a GCLSE experience in the 19th Judicial District (Weld County), the 8th Judicial District (Larimer & Jackson Counties) and the 13th Judicial District (Kit Carson, Logan, Morgan, Phillips, Sedgwick, Washington & Yuma Counties).

A critical part of the GCLSE model is providing a stipend to cover the living and housing costs during the students eight-week internship. Public interest service, and solo practice in Greater Colorado is daunting enough, without requiring students to add to their ballooning law school debt during the summers. By providing a stipend to cover living expenses for the eight-week program, we can remove a major barrier to students exploring the opportunities in Greater Colorado. In turn, we will be investing in the future of Access to Justice in Greater Colorado. It is for this reason that we are asking the Colorado Bar Foundation for your support.
