# c. FREE Record Sealing Clinic

- i. The Colorado Criminal Defense Institute, Meyer Law Office, and *Servicios de la Raza* are holding a free record sealing clinic on Saturday, November 13<sup>th</sup>, from 10am-2pm at *Servicios de la Raza*, 3131 W.14<sup>th</sup> Ave. Denver, CO 80204.
- ii. The clinic will focus on sealing records for any eligible adult CO cases. They will have on site advice from volunteer criminal defense attorneys and follow-up pro bono attorney representation in sealing services for people eligible to file.
- iii. The clinic will also have capacity to serve Spanish-speaking and noncitizen clients. This drive will focus additional resources on assisting noncitizens with legal analysis and guidance to make accurate and informed decisions related to immigration consequences and before moving forward on a decision to seal their records.
- iv. Please NOTE that this clinic is for sealing, not for juvenile expungement or deregistration.
