Angie Schmitz Ms. Angie Schmitz reported that the Section has less than last year due to support of other sections and the retreat, but we will have more soon because we are still waiting on section dues to roll in. Mr. Dan Sweetser reported that the \$5 increase in annual section dues has not taken effect so far, but will be in effect for renewers going forward. 4. Chair's Report ...... Amy Brimah a. b. Real Estate Symposium Report ...... Mr. Eric Snyder is collecting comments, and the deadline for submitting comments is August 25, 2022. The bylaws changes are related to the Legislative Policy Officer (LPO) position and requests by CBA.

Mr. Andy Toft reported as follows: The National Uniform Law Commission (ULC) and American Law Institute have been working on changes relating to emergence of new tech—such as bitcoin as collateral, and also NFTs.

It is likely that the Colorado ULC will be reviewing these recommendations and deciding whether to submit amendments to the state legislature. He anticipates a new Article 12 regarding electronic payments, and conforming amendments in other articles to match that.

# 5. ACTION ITEMS:

# **CBA/CLE** forms generally

Mr. Sweetser reported that CBA is working on updating forms that are available through CBA-CLE. Volunteers are needed to update forms. One incentive for volunteers is that the volunteer can put their name and the name of their firm on the form as a marketing incentive.

Ms. Holly Ryan reported that she is on forms committee for public trustees and will share PT relevant forms.

# CBA/CLE forms related to the HOA bill, HB 22-1137

Ms. Suzanne Leff reported that HB 22-1137 requires a detailed notice of delinquency for unit owners who are delinquent on HOA assessments. An association needs to have a complying form to satisfy the requirement, which can allow later action by the HOA if it is not complied with. There is a new state office working on HOA issues, but they have no mandate to create such a form. Mr. Sweetser

recommended that such a form could be approved by the Section, then sent to CBA-CLE to see if they will approve the form. Ms. Leff recommends that the form be free, though it is unclear whether the CBA-CLE forms library allows that. Mr. Snyder asked Ms. Leff whether the comments she has received regarding the form mean the form needs updates or additions. Ms. Leff responded that she believes that the form is correct under the law, though it may need a disclaimer.

Mr. Snyder MOVED that the Section approve submission of the Notice of Delinquency form provided by Ms. Leff, to CBA/CLE as an addition to CBA-CLE real estate forms.

The motion was seconded by Ms. Deanne Stodden

The vote was unanimous in favor.

#### Voidable Transactions Bill......Amy Brimah

Mr. Tyler Mounsey reported as follows: Mr. Herrick Lidstone is taking the lead on this bill on voidable transactions. The Business law section is going to be voting on it.

The Colorado Uniform Law Commission was in agreement on supporting the prior bill that was carried by Sen. Gardner in the 2022 legislative session. Sen. Gardner was contacted by the National ULC that the changes in the 2022 Colorado bill were too far from the national uniform law, which caused Sen. Gardner to postpone the bill indefinitely. Mr. Lidstone wants to pursue the same 2022 bill as a non-uniform law. The proposed version is similar to previous versions. Now Sen. Gardner is on board with this version but is term limited so another legislator will have to carry the bill.

There was some discussion on the uniform bill versus the non-uniform bill, as follows:

Mr. Toft stated that the biggest issue with the bill previously has been choice of law. There were also concerns about series entities such as are allowed in Delaware.

Ms. Brimah stated that Colorado's ULC cannot stray far from the national uniform law for it to be considered a uniform law.

Ms. Stodden MOVED that Section support the BLS's efforts to bring this Voidable Transactions Bill to the LPC.

The motion was Seconded by Eric Snyder

The vote was nanimous in favor
