About Us

The mission of the Colorado Bar Foundation (the Foundation) is to support justice through legal services and law-related education throughout Colorado. The Foundation is a 509(a)(3) Type 1 grantmaking and supporting organization to the Colorado Bar Association (CBA); the responsibilities of the Foundation are as defined in IRS Publication 557. All services and programs applying for grants from the Foundation are subject to the same application, review process, and standards.

The annual contributions, donations, and estate gifts to the Foundation are skillfully shepherded by the board to provide:

- Assistance with the provision or improved delivery of legal services by supporting the representation of individuals in court proceedings, furnishing advice to prose litigants, and disseminating general information about legal matters including, but not limited to, domestic relation proceedings, probate and trust administration, estate planning, immigration, evictions, and bankruptcy
- Promotion of law-related education to the public by supporting organizations that provide information and education about our American legal/justice system to community organizations and school children of all ages
- Improvement of the administration of justice by supporting our courts and judicial officers, delivering accessible information about the Colorado court system, providing child-care for litigants and jurors, and assisting law enforcement and the judiciary in performing their functions

2023 marks the 70th anniversary of the Colorado Bar Foundation. The Foundation looks forward to continuing to serve the Colorado legal community for decades to come.

Governance and Management

Due to a new cost-sharing agreement with the CBA, the Foundation expanded its staff support from a 0.20 full-time employee to a dedicated half-time manager and hired Elizabeth Akalin for this role. While Elizabeth has managed the Foundation for the past seven years, this newly expanded position has allowed her to focus solely on the Foundation, and to manage the expansion of development efforts, special events, and the bolstered grants portfolio. The Foundation is grateful for the support from the CBA that has enabled us to scale up oper-

ations to better support our community. In 2023, the Foundation was served by a dedicated group of volunteers on the board of trustees and committees. Thank you to all the volunteers for your support of the Foundation.

Financial Information

The Colorado Bar Foundation receives funding from the following sources:

- Investment income earned from its endowment, valued at \$8,568,232 as of September 30, 2023.
- Donations made via the Bar Fellows program, which consists of individuals who have made a 10-year pledge, emeritus fellows who continue giving annually after completing their pledges, and Aisenberg Society and Aisenberg Pledge Program members.
- One-time donations from individuals and corporations.

In 2022, the Foundation received a gift of \$5.2 million from the Estate of Ben Aisenberg, which has drastically increased its grantmaking capabilities. The Foundation's grant allowance is calculated on a rolling 12-quater average. Therefore, a substantial increase in grant funding is expected in 2024.

Donor Development and Bar Fellowship

This year, the The Foundation launched a program to expand and enhance the Aisenberg Society. Bar Fellows who contribute a total of \$10,000 to the Foundation are honored as members of the Aisenberg Society, whose namesake is Bennett S. Aisenberg. Fellows can now pledge towards Aisenberg Society status via individually customized pledge increments. This initiative is expected to further bolster the Foundation's grantmaking capabilities.

The The Foundation hosted the inaugural Cajun Feast & Fundraiser in June. Located at the scenic Boathouse in Denver's Wash Park, this event brought together members of the legal community in a festive setting. They hosted representatives of grantees Mi Casa Resource Center, Forge Evolution, Delta ETA Boule Foundation, Colorado Business Committee for the Arts, and Hope House Colorado as guests at our feast.



In September, the The Foundation was honored to host the annual Bar Fellows Dinner and presentation of CBA awards. This event celebrated Bar Fellowship and honored CBA Award of Merit recipient Fay Matsukage, Gary McPherson Outstanding Young Lawyer of the Year Award recipient Jackson Laughlin, and In-Memoriam Award recipients Richard Holme and James Wade. They were joined by representatives of grantee guests Rocky Mountain Immigrant Advocacy Network, Educating Children of Color, A Woman's Place, CASA of Jefferson and Gilpin Counties, and Law School... Yes We Can.




















2023 Grant Funding


Substantial efforts were made to increase the visibility of the The Foundation's grant program in 2023. This year it received a record high of 101 applications, compared to 56 applications in 2022.

- Total funds awarded: \$305,475
- Average grant size: \$4,364
- Total number of grants awarded: 70
- Percent of submitted applications that were awarded a grant: 69%



Geographic Impact

The The Foundation strives to fund as many counties across the state as possible. Our grantees serve the following counties across Colorado:



The Foundation is hopeful its Bar Fellows, partners, supporters, and stakeholders will continue sharing information about its grants program with legal-orientation nonprofits, especially in Kit Carson where direct funding is currently absent.

In addition, the Colorado Bar Foundation funded 24 organizations that serve the entire state.

COLTAF Block Grant Program

The Colorado Lawyer Trust Account Foundation (COLTAF) program supports pro bono legal services by funding local legal aid and similar organizations that provide civil representation to economically disadvantaged residents across the state. It is funded by the interest earned on client trust accounts maintained by Colorado attorneys.

Each year, the Colorado Bar Foundation provides funding to the COLTAF pro bono grants program. This funding is used to bolster the amount of available grants made to bar-sponsored pro bono organizations and goes directly to the selected grantees. With this community partnership, grantees receive funding benefits from both the Colorado Bar Foundation and COLTAF while only needing to complete a single application.

In 2023, the Founadtion awarded COLTAF a block grant of \$30,000. This collaborative funding supported the following organizations:

Works with community volunteers, law students, multidisciplinary faculty, and volunteer attorneys to exonerate those persons wrongfully convicted in Colorado.

Advances children's and parents' rights by supporting a diverse, inclusive community of child welfare lawyers to provide zealous legal representation and by advocating for equitable, anti-racist solutions co-designed by people with lived experience.
