- 2. Call for review and approval of the February 2019 Minutes. M/S/A the February 2019 minutes.
- **Chair's Report** Arlene Barringer presented. An email will be sent in the near future regarding nominations for open positions of leadership within this section.
- 4. <u>Treasurer's Report</u> Charles Spence-presented by phone. The balance in the section's account is approximately \$10,000.00. This amount does not include payment toward the Elder Law Retreat. After that payment is deducted, the balance will be approximately \$5,500.00 at the end of the fiscal year. There will be a discussion regarding increasing dues by \$5.00, making the total amount for dues \$35.00 per year. This will generate approximately \$1,500.00 for the section's use. A selling point for the increase in dues is that there is a CLE presented for 10 months which is included in this cost of dues.

This committee has revised the contents of the brochure titled "What to do When Someone Dies" and will be presenting it to Elder Law and T & E today. It will be circulated at Executive Council for comments.

ii. CLE and Publications Committee: Chair: TBD. Arlene Barringer presented. This committee is currently seeking a chairperson. Please contact Arlene Barringer or Brooke Brestel if interested in serving as chairperson or if interested in presenting a CLE. The speaker this month's CLE is Keith D. Lapuyade on the topic of

- Privity and Privacy: Recent Caselaw and Developments Impacting the Attorney Client Relationship.
- iii. Elder Law Retreat: Co-Chairs: Susie Germany and Tammy Conover. Tammy Conover presented. The 2019 Elder Law Retreat will be held on August 22-24, 2019 at the Vail Marriott. The program is almost completed and the details regarding the practicum are being finalized. Kayla Nelson may be substituting for Tammy Conover as Ms. Conover may not be at the Retreat. There will be trainings held in Spring and Summer for attorneys and vendors participating in the practicum.
- iv. Medicaid Regulatory Reform/Legislation Committee (MRRC): Co-chairs: Virginia Frazer-Abel and Eric Kelly. Eric Kelly presented. Meetings will be scheduled the first Tuesday of the month and will be held via telephone. Please contact Eric Kelly if you would like to join this committee.
- v. Probate Trial & Procedure Committee: Co-Chairs: Jody Pilmer and Zach Schlichting. Neither present. No report.
- vi. Advanced Legislative Response Team Joint Subcommittee: Cochairs: Marco Chayet and Letty Maxfield. Letty Maxfield presented. HB 19-1167 titled Remote Notaries Protect Privacy, concerning an authorization for notaries public to perform notarial acts using audio video communication. ELS and the CBA voted to support this bill. It is out of House committee meetings and will now go to Appropriations. Opponents are against the data privacy issue. There was a stakeholder meeting held on Monday. General discussion on consumer protection.
- Office of the Public Guardianship Committee (OPG): Chair: Carl vii. Glatstein presented. HB-1045 Office of Public Guardianship Operating Conditions concerning funding for carrying out duties related to the Office of Public Guardianship. The bill removes the condition that the commission and director wait to carry out certain duties until the cash fund has received the specified amount (\$1.7 million) of gifts, grants, and donations. The pilot program for the OPG is for 3 years and the primary focus is to gather data on the anticipated need. There are approximately 17,000 outstanding cases. The prediction is that there are over 5,000 cases that need the assistance of this office. We will not know what the exact need is until the process is started and the OPG is able to collect the data. At the end of the pilot project, this office will report to the legislature as to the exact need. So far, two thousand

dollars has been raised which represents seed money for this office. State Judicial believes that \$500,000 is needed to get this office up and running. There will be a meeting today at 1pm with the staff from State Judicial to discuss increasing the filing fees on probate cases in order to raise money for this office. Representative Snyder and Connie Lind will be present at the meeting.

- viii. Mental Health Committee: Chair: Jonathan Culwell presented. There was a general discussion concerning the bills presented this session
 - a. HB19-1169-Mental Health Involuntary Transportation Holds concerning the authority to hold a person in a mental health crisis through the provisions of the mental health involuntary transportation hold until the initial evaluation at the receiving facility is completed. This bill is postponed;
 - b. SB19-026-Postconviction Remedy Proceedings. This bill is postponed;
 - c. HB19-1177-Extreme Risk Protection Orders concerning the creation of an extreme risk protection order, and in connection therewith, making an appropriation This "Red Flag" gun Bill is very political and has lots of representation among various groups. Elder Law Section will not take a position on this bill;
 - d. HB19-1044 Advance Behavioral Health Orders Treatment concerning advance behavioral health orders determining the scope of treatment an adult wishes to receive under certain behavioral health circumstances. Mr. Culwell is involved in the discussions with this bill. It offers a person the ability to select the scope of mental health treatment they would like to receive. Mr. Culwell testified to the Senate committee a few weeks ago and the suggested amendments to this bill were accepted. The bill is set to pass with amendments. This is called an "Order" but there is no provision for a signature from a doctor. It is more akin to a behavioral health advance directive. The Bill is not perfect but it's a good start. Mr. Culwell and Mr. Schupbach will stay involved with this one. Thank you to both of them for their work on this bill.
- ix. Electronic Will & Remote Notarization Joint Subcommittee Cochairs: Letty Maxfield and Herb Tucker. Ms. Maxfield already discussed Remote Notarization above. Per Mr. Schupbach, the CULC is reappointed each year. Those who did not favor Electronic Wills were not reelected this year. He does not have assurance from the Commission that they have no interest in this

bill. Hence this bill may resurface. Per Mr. Kirtland, the Uniform bill could be passed at the end of April. General discussion.

- x. Uniform Guardianship, Conservatorship, and Other Protective Arrangements Act Subcommittee: Co-chairs: Catherine Seal and Brooke Brestel. Arlene Barringer presented. The Bill of Rights is postponed indefinitely. Ms. Brestel and Ms. Barringer testified regarding this bill. It is dead this year but will resurface next year. This summer will be used to address the proponents' concerns regarding guardianships. Ms. Liska, Ms. Brestel and Ms. Seal will set an agenda and invite proponents of the bill to review parts of the uniform bill so they can report back to the legislature next year. The sponsor stated the bill is poorly drafted. The meetings will commence in May.
- xi. Subcommittee for Fiduciary Duties and Entities: Chair: Scott Challinor presented. No report.

b. Liaison Reports

- i. Board of Governors: Marco Chayet not present. No report.
- ii. Legislative Relations: Jeremy Schupbach presented.

The Disability Trust Bill. LPC and this section voted to support this bill. The next step is having leadership move on this bill. Most likely this bill will die. Person created this bill with no sponsors therefore this bill has been orphaned. Leadership is not sure what to do with this bill. Until this bill is made a priority, there is nothing this section can do. Eric Solem was the primary drafter of this bill and discussed it last month at the Elder Law Section general meeting. This bill impacts people in this state and those who want to move out of the state.

SB-172—Protect From Unlawful Abandonment And Confinement. This bill concerns crimes related to an at-risk person, and, in connection therewith, creating the crimes of unlawful abandonment and unlawful confinement. This bill increases the crime from a class 1 to a class 6 felony. Mr. Schupbach consulted with the Criminal Law section because of the change from a misdemeanor to a felony. Mr. Schupbach has a meeting with Senator Ginal. This bill needs to be considered by this section. General discussion. Ms. Zumalt will work on a memo concerning this bill and list the consequences should it

become law. The bill will be discussed at the ELS Executive Council meeting today.

- iii. Trust and Estate Section Liaison: Patrick Thiessen presented. No report.
- iv. SRC Liaison: Nancy Peterson/Mallory Hasbrook. Nancy Peterson presented.
 - a. Abandoned Estate Planning Documents-The new Secretary of State does not share the prior Secretary's views on this bill. Negotiations will likely be reopened.
 - b. Child Support in Probate Subcommittee-Pat Mellen has recruited a counterpart from the Family Law section. The next meeting will be March 20th at LawBank. Contact Pat Mellen (pat@patmellenlaw.com) if you would like to participate.
- v. Outreach Coordinator: Mallory Hasbrook not present. Nancy Peterson presented. See CBA YLD Liaison below.
- vi. Communications Representative: Paige Armstrong not present. No report.
- vii. CBA Legislative Policy Committee Liaisons: Brooke Brestel/Patrick Thiessen. Brooke Brestel presented. LPC approved the disability trust statute and remote notarization.
- viii. UTC Committee Liaison: Michael Kirtland presented. This committee is reviewing section 5-Creditors Rights.
