Call to Order – Suzanne Leff 3:01 p.m.

- 1. **Introduction of guests and all attendees** Suzanne Leff
- 2. **Approval of May Minutes** Suzanne Leff –approved unanimously
- 3. <u>Financial Report</u> (\$75,219.11 as of May 31, 2019) Melinda Pasquini High balance because all July expenses not yet reflected, including costs of Symposium. Also, most income for entire year is reflected with annual dues payments. Suzanne For future budgets, we will be evaluating additional activities that may provide more value for our members.
 - a. **Chair's Report** Suzanne Leff.
 - b. Symposium Recap – Thank you. Thank you to speakers, bed bugs, Joey Lubinski fill-in, etc. 407 people in attendance (average 405 in past). Good reviews. Some would like to see beginner track, which would require a change in the current facilities. Polls in between sessions were good considering first time included in Symposium, but there is room for growth in terms of increasing participation in polls. Bridgett Shephard – thank you for organizing a Symposium that ran incredibly smoothly. Many ideas for 2020. Reviews very positive. Consistent attendance year after year really great. 20% new time attendees. Discussion regarding trends of first time attendees, how many Symposiums, how often attend, and other statistics. This is the largest section event of the year. The Opportunity Zones ("OZ") presentation speakers would like to find a way to engage real estate attorneys throughout the State. Still trying to figure out engagement in OZ at state State looking at small OZ grants to assist in finding investors for projects. Working on a list of approved vendors who can consult on OZ and real estate and business attorneys would be great volunteers. Specifically, they are looking for those who may be associated with Limon, Ft. Morgan and Walsenburg affordable housing projects with OZ. Would also like to find people who are experienced in entitlements in these areas and affordable housing procedures to coordinate with OZ process.
 - c. Committee Appointments Ms. Leff has most committee preference sheets and is working on committee assignments.
 - d. Section Nonrenewals July 1st is the start of bar year and time for renewal. Not all members have renewed. All Section Council members must have dues paid to be on RESC. When first looked at non-renewal numbers, they seemed high, approximately over 100 non-renewals. We have, however, made up non-renewals with new members. Will look again after another month and start contacting those who have not renewed.

ACTION ITEMS

4. **CCIOA Task Force** – Suzanne Leff – Governor vetoed bill that would have renewed licensing for community association managers. Executive Order issued that requires formation of a stakeholder group. DORA has formed this stakeholder group. 4 stakeholder meetings centering around Managers as well as being more transparent with owners. One meeting related to CCIOA, touches on CCIOA plus uniform act changes. Appropriate for RESC to look at CCIOA and address issues more proactively. Convene a task force charged with attending stakeholder meetings, report back to RESC, review CCIOA and proposed changes and potential issues. Chris Payne volunteered to chair task force. Objectives are to be engaged in stakeholder process and review CCIOA in connection with new CCIOA. Motion made to form task force chaired by Chris Payne. Second. Unanimously Approved.

5. **New Liaison Positions -** Suzanne Leff

- a. Regional Liaison This position serves in the role of engaging attorneys outside of Denver metro area who may have different interests and needs. Doug Tueller based in Telluride has brought a different perspective while he was on RESC. Mr. Tueller identified priorities: engaging other attorneys on local/regional issues and communicate back to RESC, getting input on legislation from attorneys outside of metro area, identify good nominees to serve on RESC from outside of metro area. Appoint Mr. Tueller as initial regional liaison (under article 8 of bylaws can make new liaisons approval of RESC for new liaison). Robin Nolan asked if liaison would be a person who brings info back to attorneys in Telluride. Doug Tueller said both inbound and outbound feedback and eventually model for other regions in the State. Chuck Calvin mentioned Mr. Tueller should identify other people for other areas of the state. Suzanne Leff stated this is already a CBA model for different regions and mirroring CBA regions. Motion for Chair to authorize a new Regional liaison. Second. Unanimously Approved.
- b. Professional Organization Liaisons Professional associations that we may align with on various real estate and legislative issues. Not specific to one professional organization but a liaison role for section members who already belong to other professional organization. For example, Damian Cox and CAR (Colorado Association of Realtors). Proposal to create Professional Liaison Position, the first position with CAR and Damian Cox as initial liaison. CAR approached RESC on this. Attend CAR/RESC meeting and report back to interface between professional organizations. One liaison for each professional organization. Start with CAR and consider additional liaisons for the future. Chuck Calvin survey of RESC to identify organizations RESC members are involved with. Motion to create a professional liaison position to CAR from RESC with Damian Cox as the liaison. Second. Unanimously approved.
- 6. Title Standards Table of Contents: Approval for publication Suzanne Leff Ms. St. Paul requested permission to publish CO title standards table of contents. Motion to approve. Second. Unanimously Approved.

REPORTS AND INFORMATIONAL ITEMS

- 7. **Attorney Certification on Fort Collins Plats** City of Ft. Collins requires Attorney representation on plats that all parties with an interest in plat have signed and have authority to sign. Chuck Calvin is only aware of Ft. Collins doing this and they do not allow you to change. Since on plat could be in privity with anyone since of record. Some firms will not do it and hire local Ft. Collins counsel. There are people who will sign off and Land Title product for insurance for attorneys signing off. Another alternative is to negotiate indemnity with client. There was a discussion on whether we should coordinate with local bar to determine if there have been any issues with this. Not a new problem but continues to come up. Julie Waggoner pointed out that opening discussions could risk other municipalities adopting a similar approach as Ft. Collins.
- 8. <u>Franklin Credit Management Corporation v. Galvan (Colorado Court of Appeals, July 11, 2019)</u>: Judgment liens on real property and request for Amicus Brief Geoff Anderson's client on losing side may authorize a petition for cert. No judgment necessary to exercise writ of execution on real property. There was a discussion on whether this is an issue for RESC to weigh in on and it was noted that the creditor's bar believed the reasoning in the opinion seems correct.
- 9. <u>Landlord/Tenant Legislation</u>: Aurora Eviction Case and Late Fees Jean Arnold Landlord/Tenant legislation now a potential class action suit pending. Late fees, service fees, and owing more in fees than rent itself. Case states fees are interest and usury. This could come up in legislation session.
- 10. <u>Short Term Rentals</u> Jean Arnold Indictment of couple for misrepresentation on primary residence to get around Denver short term rental ordinances. Denver is actually enforcing this as a criminal indictment claiming false affidavits were signed by the couple.
- 11. **Acronym Glossary for Orientation Manual** Melinda Pasquini RESC acronyms Work on a way to post a glossary for everyone to add to.
