5. Thank you to "graduating" Council Members (future involvement) Joey Lubinski

We are waiting on the cubes for your desks – thanking you for your service. We have 4 people who have dedicated time to this Council for the past 3 years: Doug Tueller; Robyn Kube; Damian Cox; Melinda Pasquini. Everyone is interested in continuing in an active capacity. So this is not goodbye - but a transition.

6. **Election to fill 2019-2020 term of Jed Sonnenshein** (resigned in May 2019). Jean Arnold

The Council has a one-year opening to fill to complete the last year of Jed Sonnenshein's term. Doug Tueller and Robyn Kube have both expressed interest in filling the remaining one-year term. Ms. Kube and Mr. Tueller spoke about the Council and their qualifications to serve out Mr. Sonnenshein's term. Ms. Arnold reviewed the Bylaws and procedure for filling vacancies on Council:

In the event of a vacancy created by operation of this Section 4.4 or any other circumstance, the remaining members of the Council shall elect, by majority vote at a meeting in accordance with Section 10.3, a member of the Real Estate Section to fill such vacancy and to serve for the unexpired term of the office or Council position vacated.

Robyn Kube will fill Mr. Sonnenshein's position – she won by one vote (with one Member abstaining).

Suzanne will contact Doug Tueller about a Liaison position.

7. **Governor's Veto of HB1212 Community Association Managers** Suzanne Leff

Governor Polis vetoed the HB1212 – the veto was a surprise as Suzanne Leff has seen the value of licensing. The Governor vetoed 3 different licensing programs – this is one of them. DORA has issued guidance that they will not be doing anything to regulate managers. The Executive Order issued by the Governor establishes a stakeholder process.

Stakeholder Meetings – DORA is soliciting participants and Joey Lubinski has signed up for the CBA. CCIOA is opened up for evaluation.

Mr. Lubinski must get CBA backing for any position, but RES is interested in this issue. Real Estate would like to convene a task force on CCIOA. Before the licensing act, there was a task force on CCIOA issues. Super-priority issues with the mortgage lenders. Ms. Leff wants to know who would like to serve on the CBA task force. Please contact her if you would like to serve.

Chris Payne in interested in serving on the Task Force. Initial licensing bill – Real Estate Commission staff were involved in managing the public outreach and had a survey.

Suzanne Leff will circulate the survey and everyone can take the survey that DORA is circulating. Part of the issue is that the UCIOA has been updated and recently undergone a review. Therefore a broader Task Force on CCIOA is relevant and could open up a variety of issues. Mr. Lubinski reports that one of the UCIOA committees was a "study" committee and came up with a 50-page report and would serve CBA well to begin the review.

The only other item of note was a comment by Patrick Flaherty that the Bylaws changed in 2017 so that the Executive Committee can now approve all title standards without the need to go the Board of Governors. So that should streamline the approval process for future standards.

Title Standards is looking for projects and topics.

Melinda Pasquini: Mineral title standards is of interest – North Dakota title standards are very helpful.

– Uniform Law is coming out with an act for electronic Wills. Jeremy has been discussing with T&E. Big issue down the road.

Mr. Payne reports: Aging lawyers and closing of solo and small firm practices could be a possible topic for joint meeting or luncheon. Mr. Payne reports that last year, the Office of Attorney Regulation Counsel:

Reviewed 3,586 requests for investigation against lawyers

and

Inventoried 5,890 client files for attorneys who died, became disabled, or who could otherwise no longer handle their professional responsibilities.

The Colorado Bar faces a greater continuing challenge with attorney age/disability, than attorney competency/ethics. This is not unique to the real estate section, of course, but Mr. Payne encourages us to join with others for solutions. Perhaps we can invite someone from OARC to speak at a section meeting or a lunch.

Joint Legislative Update presentation went well. Best attended program of the year for Tax luncheons. The Tax Section is looking for a less expensive venue than the Brown Palace for future meetings – there are many call-ins for the meeting due to cost, but also for convenience.

23. **Board of Governors**

Katy Dunn / Dan Sweetser

Report from Dan Sweetser, President-Elect to the Denver Bar Association

Meeting was at the Cheyenne Mtn. Resort. Well attended. Patrick Flaherty gave his report. The CBA needs to communicate better with members: 18,000 members. Not everyone knows what the Board of Governors does or what the CBA does.

First solo / small firm convention was very well attended. A lot of lawyers from outside asked about the "Bar Convention" and what happened to it. They enjoyed the networking and social time and coming from around the State.

CBAs work on legislation at the Capital is respected.

Modern Law initiative – unbundled legal service was discussed.

CNA Insurance is now partnering with CBA for malpractice insurance – especially for young lawyers.

CLE ratcheting up their member discounts. Solicit response from members.

Open pro se clinic – with Federal Court – the Federal Courts have a grant. There is a lot of work to be done to get people to the "right" court.

CBA has a budget surplus; but the CBA's dues are the second lowest dues of any bar association in the country. The CBA has 12-18 months of free rent in the current space, so the budget will be affected once that lease concession concludes.

Membership numbers are up. Around the country there is a 3% drop in membership.

The CBA wants to keep young lawyers involved and participating. Joey Kush – YLD was very active. Regional ABA YLD summit in Steamboat. Next year in Lake Tahoe. The CBA has money to sponsor a YLD member to attend.

Jeremy spoke on the legislative session.

John Vaught spoke on new procedures for the Legislative Policy Committee. LPC needs to not take a political position. Mr. Vaught gave his President's report on Broadband Infrastructure – access to Justice; access for lawyers. CO is taking the lead at the ABA convention in August to ask for money to get broadband throughout the country. Mr. Vaught hopes to strengthen the regional vice presidents. Denver is a bit of "bubble." The CBA wants regional diversity. Emma Garrison reported on a new 'best practices' guide to give the regional vice presidents some guidance.

Watering Fund – maintained to help disabled lawyers. If know anyone with an issue, there are funds for lawyers that are having troubles (physical, psychological, substance abuse).

Cannabis Law Committee is now a Section.

COLAP gave their presentation. Sarah Meyers will be leaving as Executive Director and Chip Glaze will be the Deputy Director.

OARC – Issues with aging of lawyers and disability associated with the aging.

CJ Coates – 15 new judges, but still need more judges to deal with civil cases. Getting younger judges now. Infrastructure work needs to be done in courthouses around the state to improve access.

CBA President-Elect, Jessica Brown, is from Pueblo and will bring regional diversity to the CBA.
