- 1. **Call to Order** Joey Lubinski 3:02 p.m.
- 2. **Introduction of guests** Joey Lubinski

- 3. **Approval of <u>June Minutes</u>** Joey Lubinski
 - S. Leff noted a misspelling of McKay. After making the change, R. Jung moved to approve and the motion was seconded. Passed: Minutes approved as corrected.
- 4. **<u>Financial Report</u>** (\$77,564.64 as of 7/31/2018) Jean Arnold
 - S. Leff pointed out that \$10,000 was to be deducted for the Section's sponsorship of the Symposium. The funds have not yet been deducted and A. Sreenen noted that the CBA anticipates the funds will be transferred in August.
- 5. **Chair's Report** Joey Lubinski
 - J. Lubinski reported the following:
 - a. Symposium Recap

The Symposium went well and the ribbons for first-time attendees and council members were generally well received. A. Sreenen noted the other sections are doing the same thing now.

- J. Lubinski also noted that the **school supply drive** for the Action Center went well and congratulated R. Kube and her committee on revitalizing the Community Service / Charitable Committee.
- b. New Year Planning

J. Lubinski reported that goals for the current bar year include membership development and community outreach. J. Lubinski noted that all Council members should feel comfortable expressing their positions and asking questions.

c. Diversity Liaisons

Council voted to create new liaison positions with LGBT Bar Association and J. Lubinski again welcomed **Julie Baird** from First American Exchange 1031. She is attending her first meeting of the Council.

The Real Estate Section's core constituency is 400 out of 1400 members of the CBA. J. Lubinski's goal is to increase active membership and to achieve cross over to other sections and get others involved as liaisons, task force members and guests to strengthen the Section and the CBA as a whole.

ACTION ITEMS

6. **Title Standards Table of Contents – Approval for publication by Thompson Reuters.**Suzanne Leff

Thompson Reuters (West) is requesting permission to publish the table of contents to the Title Standards. Title Standards is a committee of the RESC, and the Real Estate Section holds the copyright. The Real Estate Section has the copyright on all of the Standards that come out of the committee. A discussion ensued regarding the matter, including noticing that following:

- The committee approved changes to two sections and issued a new title standard since 2017.
- The Standards will change after October: Executive Council has to approve one more and then publish.

Motion by R. Jong: Publish table of contents with link to website location of title standards, subject to follow up with Attorney's Title regarding distribution limitations. Seconded. Passed.

7. Amend Bylaws to correct statements about LPC "liaison." Suzanne Leff

Ms. Leff noted the necessity to revise the Section bylaws to address an error regarding the LPC. The bylaws provide that the Section Chair will appoint a liaison to the LPC, but that is not in fact the case. The CBA Executive Committee and the Board of Governors select members to the LPC.

Motion to: delete Section 8.1(f) of the Bylaws. R. Jung. Seconded and passed by voice vote.

REPORTS AND INFORMATIONAL ITEMS

- 8. <u>Do I Need a Lawyer When I Buy or Sell My Home</u>? Liz Deline
 - L. Deline prepared an updated draft of the original 2001 document. J. Lubinski requested that Council members provide Ms. Deline with feedback so that an updated version can be posted.
- 9. <u>Ryan Ranch Case</u> Potential Legislation Leff

Joey Lubinski and Suzanne

J. Lubinski noted that the *Ryan Ranch* Colorado Supreme Court decision has given rise to concern among communities regarding the validity of various annexations into their communities. Under the supreme court decision, strict compliance with the requirements of CCIOA is required and annexation by deed in the manner undertaken in this case did not meet those requirements. J. Schupbach noted that the CBA has been contacted regarding the need to address the outcome of this decision. It is anticipated that the Section will need to continue to monitor this situation, especially in light of the *Perfect Place* case on the standard for CCIOA compliance that was recently granted cert.

10. Affordable Housing Task Force

Doug Tueller

The Task Force discussed the merits of a white paper vs. inventory approach surveying the different approaches to affordable housing in Colorado. A discussion ensued regarding the news items from the Spring regarding Denver's affordable housing program and the manner in which other communities address these matters.

11. Remote Notarization/Uniform Laws Update Lubinski)

Chuck Calvin (Andy Toft, Joey

J. Schupbach reported that he went to Kentucky for the Uniform Law Commissioners annual meeting. J. Schupbach reported that while many of Colorado's concerns with the uniform remote notarization bill were not addressed, Colorado is seen as a leader on this issue. Mr. Schupbach expects that the uniform law will be introduced in Colorado next session and that familiar battle lines will remain. J. Schupbach noted that the sale of consumer data remains a very important issue with the legislation.

12. Residential Grant Deed Update Cox

Joey Lubinski and Damian

J. Lubinski reported that a meeting was held with LTAC at Land Title's office to discuss LTAC's proposal for a "new" deed form to be used in Residential transactions. It appears that the new deed form will not proceed, but that the deed statutes may need to be revised more generally. A task force consisting of D. Cox, D. Tueller, R. Nolan, B. Dowling, R. Jung, D. Sweetser, and C. Calvin was appointed to discuss this matter further to advise the

Council on revisions to the deed statutes and participation in helping draft new LTAC legislation.

13. Update on FinCEN cash buyer program (Article): Chuck Calvin

Mr. Calvin reported on continued developments on FinCEN's geographic targeting orders pertaining to the disclosure of beneficial entity ownership in cash transactions. Based on a Miami Herald article and information received from Kevin Shepherd from the ABA, it appears that the beneficial ownership disclosures may become a nationwide requirement for cash transactions of a certain size. C. Calvin noted that he has been involved in a recent transaction where a form regarding beneficial ownership was required by the title company.

14. Legislative Update

J. Schupbach estimated that there are about 25-30 bills anticipated that will be of particular concern to the CBA, with about half of those bills being uniform acts. For Real Estate, J. Schupbach anticipates that affordable housing and Airbnb will be hot topics.
