#### **ACTION ITEMS**

5. **Revision to §38-35-101.** 

Catherine Hance

**Purpose:** Changes tie into provisions under the Uniform Notary Act passed in the 2018 Legislative Section. In response to comments last week, Title Standards made a few "clean up" changes. For review are the cumulative changes – December, January and February (last week). The legislation ties in how a notary determines the person is known or identified. Section 2

changed the form of the acknowledgement. Section 3 says that if the acknowledgement conforms, and the acknowledgement was made as required in Section 1, then the presumptions apply. This legislation is necessary to conform with the Uniform Notary Acknowledgement Act and to conform with the provisions and make the presumptions conform.

Title Standards is asking Section Council for comments; if this proposed legislation is approved, then send to LPC for comment and approval. Next, a sponsor will be needed – maybe for next 2020. Catherine Hance, Julie Waggoner and Geoff Anderson thank RESC for working on this legislation over several months. The proposed legislation is a necessary fix because of the passage of the Uniform Notary Bill in 2018. Doug Tueller moves to approve the proposed legislation and to ask LPC to endorse. Damian Cox seconds. Discussed occurred about whether to approve now or wait until next Session. The consensus was to approve now so that a sponsor can be found. Vote: unanimous to approve and refer to LPC. Title Standards (Catherine Hance) will present to LPC

6. Real Estate Course will be completed March 12, 2019. Last year, RES sponsored a celebration and happy hour. Course ends March 12, 2019 at 6:15 p.m. \$500 will be needed to sponsor. Robyn Kube moves and Damian Cox seconds the motion. Passed. Joey Lubinski reminds member to attend.

#### 7. <u>HB19-1108</u> Special Districts

Joey Lubinski

Doug Tueller described the legislation and the proposal of voting by non-resident electors. Mr. Tueller described the legislation in the Town of Mountain Village, Telluride. This bill was vetoed last year by the Governor. Jeremy Schupbach will research.

Mr. Schupbach reports that he talked to Michael Valdez. The House made amendments to the Bill and passed it 34-28. He will forward the amended version for review by Mr. Tueller and Robin Nolan. Passage is tenuous at best. The Bill's scope is narrowed. The Clerks opposed and added a poison pill to include a verification process that is so onerous that no one will do it. Special Districts are against it. Fire Fighters are against it. The Bill will pass the Senate in the next few days. It is on the Consent calendar. So there will be no further amendments. The amended bill narrows the board of directors and is an "opt in" statute. The Clerk and Recorder does not have to handle the elections. There is also an income verification process. The verification amendment is 5 pages long. Valdez would request and oppose. Week of March 4 the Bill will be in the Senate. LPC meets on March 1, 2019 so we have time to review and go to LPC next Friday if needed. Robin Nolan will review the Reingrossed version forwarded by Jeremy.

# **SB19-107 Broad Band Infrastructure** (In committee)Brianna Dowling/Jeremy Schupbach

Amendments to SB19-107 expected. Definitely a topic at the bar. John Vaught's Bill. Reviewed Brianna Dowling summary. Jean Arnold will forward Brianna's email to Jeremy. Counties and providers are reviewing sections. Monitor for now. Mr. Schupbach expects changes to the Bill.

SB017 CDOT Eminent Domain (Amend – Crossed over).

SB047 Remove Unauthorized Persons from Vacant Land (Oppose – Dead/Failed)

HB19-1098 Deed Bill (Monitor – Crossed over) Amended. Voted in the fall to endorse a previous iteration. Did not bring up for another vote. RESC did not take a position. Members of RESC assisted in drafting. Some of the issues were addressed in the amendments: (1) Title company liability – cannot disclaim for negligence when prepare deed; (2) Title Company can only prepare a deed in connection with issuing a title policy; (3) Location of where reference to "statutory exceptions" appeared in deed form was changed a "blank;" and (4) Later in the statute, the "statutory exceptions" language appears, but is not the default in the form.

Concerns from the surveyors were addressed: if the statutory exception is for off record matters – ILC may be used but does not meet the statutory exceptions required: Only matters that show up in a full survey. No exception for things the Seller did and knew about, but failed to disclose.

Status of covenants grantor should include: heirs, <u>successors</u> and assigns; page 6, line 26. The word "successors" was left out. RESC has taken no position on the bill. Send the language to LTAC – Peter Griffith. The "successors" language was missed. Mr. Schupbach reminds RESC of the Procedure – since RESC did not take a possession. This Bill is very close to the Governor's desk. To add the "successors" language, it may have to go back through 4 votes. RESC wants the issues fixed, but the best way is through LTAC or a cleanup bill in the 2020 Session.

SB19-084 Uniform Remote Notarization (Monitor – Dead/Failed)

HB1118 – Lease Cure Period (Amend – In committee). The amendment requested is approved: carve-out for commercial property. The notice time frame is still under debate.

**HB1145** – **Primary Residence Exempt from Liens for Medical Debt (Oppose)** – Suzanne Leff. Remove "shall" from the statutory amendment. Opens up the whole section of the statute and may address *Huddlestrom*. RESC has voted to oppose. Jeremy Schupbach will check on availability of LPC for a vote before Thursday's hearing. Jean Arnold can attend if needed.

Note: evening follow up. No need for memo before Friday's LPC meeting. Hold until Jeremy Schupbach gets back to RESC as to next deadline.

HB1167 – Remote Notary Bill (Support – In committee) – Chuck Calvin attended a half day hearing. The Bill got half way through the house and February 25 the Bill will advance through the second half. CBA did a good job of supporting the bill. Notarize claims to have never shared data, but wants to have the right to do so. Legislators are telling CBA to compromise. Notarize is not interested in any compromise except "their" way. Terms of service

have been "updated" by Notarize. The passage of bill with Notarize's determined opposition is tenuous at best. Notarize now opposes all the parts they agreed to last year. Notarize's forms were removed from the Bill. Service of process was amended to be on the Registered Agent with the Secretary of State. For the past 2 ½ years CBA has shown good faith. SOS is threatening a fiscal note (none yet). SOS is taking a very aggressive line on anything that may have the SOS spending money.

HB 1170 Warranty of Habitability. Joey Lubinski has provided thoughts on the Bill. The Bill was heard in committee on Friday (2-15-19). Some of the requested amendments were made. Mr. Lubinski will review what came out of the House and decide whether to go to LPC this Friday. Be prepared for an electronic vote this week before LPC's Friday meeting. Amendments include: (1) Definition of mold; (2) Addition of appliances as part of the WHO; (3) Hotel accommodations; (4) Appliances does not flow through to the remedies section. CBA Opposed last year. The sponsor want the CBA to reach a neutral position.

#### 9. Colorado Housing Council

**Opportunity zones.** Technical and the benefit is temporary. Non-lawyers are not excited about this. Will have a topical lunch on the issue in April. There are enterprising Plaintiff's lawyers – if an attorney does not bring the existence of an opportunity zone to their client's attention then malpractice. There is a State website where the location of an opportunity zone can be seen.
