- 1. **Call to Order** Jean Arnold. Ms. Jean Arnold called the meeting to order at 3:07 and led a wellness activity related to community prior to calling the meeting to order.

- 4. **Chair's Report** Jean Arnold

a. Committee Appointments......Melinda Pasquini

Ms. Melinda Pasquini discussed that the first meeting for new members will be in August. The committee descriptions were sent out and Ms. Pasquini wants to have the appointments made by the first meeting.

b. Proposed Changes Bylaws......Melinda Pasquini

Ms. Pasquini discussed bifurcating the legislative position from Secretary. It would be a multiple year position that works with the Secretary and stakeholders. Ms. Pasquini presented the proposed budget. Ms. Pasquini discussed the different columns and what was budgeted and what we ended up doing. Ms. Pasquini went back to 2019 to compare to a year that was not COVID year for a better understanding. We

keep increasing the amount of money we are retaining. Ms. Pasquini proposed spending an extra \$9,000. Our membership increased during the pandemic, it was predicted there would be a decrease. Ms. Pasquini's goal is to continue to increase our membership. Ms. Pasquini added a new line item \$1,500 as new member outreach. Ms. Pasquini went over the other items of expenses in the budget.

d. Proposed ALTA's Owners Policy.....Jean Arnold

Ms. Arnold commented that the proposed ALTA's Owners Policy was included in the packet.

e. Telluride Warehouse CBA/CLE.....Doug Tueller

Mr. Doug Tueller discussed the background for doing the CLE in Telluride. All day CLE focused on art, real estate and the new west to be held in Telluride at the Warehouse which is going to be a new art center. The focus will be on the Western Slope, arts districts in rural Colorado, funding and real estate transaction related issues. They are also going to include a DEI component and try to get an ethics hour. Ms. Kendra Yates commented that this will be the beginning of coming out of COVID. The CLE will be on 9/24/21. Ms. Arnold suggested that a driving suggestion also be included.

### 5. Legislative and Executive Order Updates

a. Legislation- Andy White and Amy Brimah

Mr. Andrew White and Ms. Brimah reported that LPC tabled SB 173.

HB 1229 received a proposed strike below, it is not clear if the Rep. Titone supports the strike below.

HB 1278 the requested amendments will be made.

b. Executive Order Update – Andy Toft

Governor Polis extended emergency declaration for another thirty days. Ms. Arnold thanked Mr. Toft for all of his work.

Mr. Chris Payne commented that the strike below bill should have the same comments that were previously provided. There are additional provisions related to voting proxies but those are outside of our comments.

### 7. **Eviction Task Force** https://leg.colorado.gov/bills/sb21-173

Ms. Angie Schmitz testified at the hearing. Ms. Brimah thanked Ms. Schmitz for her work chairing the eviction task force.

#### 8. Access to Justice Liaison

Mr. Toft reported on the State Access to Justice Commission has been working on, they are pursuing a path of reforms to county courts that deals specifically with FEDs. It is based upon a form used in Denver County courts that would be used state wide. Certain disclosures may also be required in the filing of an FED. If SB 173 passes as is, it will conflict with the proposed amendments. If the bill dies, the rule changes will likely go forward quickly.

#### 9. **CBA Cannabis Law Committee**

Mr. Eric Jaworski reported that the section is following legislation related to banking, delivery and transfers between retail and medical. They are also following the CDPHE testing of Hemp.

That means the Colorado Court of Appeals' decision will be binding authority.
