Call to Order – Jean Arnold called the meeting to order at 3:02 p.m.

- 1. **Introduction of guests, liaisons and staff** Jean Arnold- Each liaison, staff and guest introduced themselves and gave background information on themselves.
- 2. **Approval of September Minutes** Jean Arnold- Unanimous approval of September minutes.
- 3. <u>Financial Report</u> (\$120,338.35 as of <u>September 30, 2020</u>) Ms. Brimah reported on the current financials.
- 4. **Chair's Report** Jean Arnold
 - a. Ethics Liaison Ms. Arnold introduced Kate Strauss as the new Ethics Liaison.
 - b. Leadership Summit. Ms. Arnold reported on the CBA Leadership Summit.
 - c. Diversity Ms. Arnold discussed importance of diversity and inclusion and encouraged RESC members to take the diversity survey. https://www.surveymonkey.com/r/Y8TZV6Q.
 - d. Ms. Arnold reported on the change to an Application for membership with the RESC (rather than nomination). Application form will be on the CBA website. We will send out with the link to the application when we call for "applications" rather than nominations.
 - e. Ms. Arnold notified RESC that we will need to amend Bylaws to change "nominations" to "applications". This will be an action item in 2021
 - f. Colorado COVID-19 Legal Relief. Ms. Arnold reported on COVID-19 efforts by Mr. Toft.
 - g. Virtual Records Ms. Arnold reported on Colorado Lawyer article regarding court reporting.
 - h. Holiday Party Ms. Arnold asked to save the date in December for the 3rd Tuesday in December for a modified Holiday gathering outside and socially distanced (or

may ultimately take the afternoon off depending on the current pandemic environment).

i. <u>"21-Day Racial Equity Habit-Building Challenge ©"</u> - Ms. Arnold challenged RESC members to take the Racial Equity Challenge outlined in the CBA Loop.

ACTION ITEMS:

- a. Diversity Statement. Ms. Arnold reported on the Diversity statement adopted by CBA and also being adopted by each of the Sections. Ms. Brimah 1st. Ms. Dolan 2nd. Unanimous Approval to adopt diversity statement as part of our governing documents along with Real Estate Section bylaws.
- b. Written Reports for Committees and Liaisons. Ms. Arnold described the process and expectation for committees and liaisons submitting written reports prior to monthly RESC meetings. Ms. Brimah described benefits of new standard for submitting written reports.

REPORTS AND INFORMATIONAL ITEMS

5. Ms. Arnold described the following recent case: September 8, 2020, No. 20SC292, Court of Appeals Case No. 18CA2250, Lo Viento Blanco, LLC, v. Woodbridge Condominium Association, Inc.

Petition for Writ of Certiorari GRANTED. EN BANC.

Question: Whether, under Colorado law, an adverse occupier's acknowledgement or recognition of the owner's title during the occupant's claimed prescriptive period interrupts the prescriptive use and defeats the presumption that any use was adverse. Note: During the prescriptive period, the claiming party sent a letter offering to purchase the land.

- 6. **Legislative and Executive Order Updates** A. White, A. Brimah and M. Pasquini and A.Toft
 - a. Mr. White gave background on lead-up to legislative session and what to anticipate leading up to new legislative session. Secretary of State has received draft rule on Remote Notary and that is being worked on by the RESC task force.
 - b. Uniform Laws Ms. Brimah reported on the Easements Relocation Act and Partition of Heirs Property Act at the Uniform Laws Commission. Mr. White described work with other sections on this matter.
 - c. Executive Order Update Mr. Toft reported on Executive Orders.
 - d. Gallagher Amendment Ms. Pasquini reported on the Gallagher amendment repeal and potential for legislative action if the repeal passes.

- 7. **CBA Tax Section.** Ms. Collins reported on Tax Section activities in recruiting outside of metro Denver area.
- 8. **Education/Topical Lunches Committee**. Mr. Meseck reported on October luncheon by Ms. Michelle DeVoe on environmental issues in real estate. Next month Patti Powell is speaking on well-being and inclusion. Ms. Mowry and Jaime Jost will be speaking next year on the changes in rules surrounding mineral rights.
- 9. **Communications.** Ms. Dowling reported on status of the Fall newsletter.
- 10. **Education/CLE Committee.** Mr. Jung reported on Fall Update on November 20th.
- 11. **Colorado Lawyer Committee** Ms. Nolan reported on upcoming articles for Colorado Lawyer: Small planned communities, marijuana, case law update, and Judge Espinosa on evictions.
- 12. **Community Service/Charitable Committee**. Ms. Clark reported on attorneys and law students volunteering as poll watchers. Ms. Clark described the training and possible duties during early voting and election day and shared resources if interested in serving in these roles.
