If not, maybe use both ("his or her" as at the bottom of the second column).

4. Amendment to effectuate consistency between C.R.S. 815-14-421(6)(a) and 815-14-708

The amendment was approved unanimously via email.

5. EP retreat budget- vote to approve \$10,000 from section to bring in speakers

Council approved up to a \$10,000 budget via email.

I attended the CBA Real Estate Section Council ("RESC") meeting on 01/19/21. It was conducted on Zoom. The following is my report on matters addressed which the CBA Trust and Estate Section Council

("TESC") might find of interest:

#1) Succession to Service Program.

Ryann Peyton from the CO Supreme Court spoke about the Succession to Service Program. Using a web based platform, it is a statewide initiative to match Colorado lawyers and judges with *pro bono* opportunities. Please visit www.successiontoserve.org to learn more and to register.

#2) Addressing Race-Based Restrictive Covenants in the Public Records.

The Real Estate Section Inclusivity Task Force is brainstorming options to address race-based restrictive covenants in the public real estate records. They are unenforceable through case law and statute, but highly offensive as part of the history of properties. The challenge is how to comprehensively redact or void these provisions without disrupting the integrity of the public real estate records. Legislative ideas include a declaration of redaction, instructing government entities or title companies to go in and redact the covenants, or compelling HOA's to file new covenants.

#3) Proposed Changes to Ethics CLE Requirement.

In its push for greater diversity, equity, and inclusivity; the Colorado Supreme Court is proposing that 2 out of the 7 ethics credits required to be earned by lawyers every 3 years be satisfied specifically by CLE's on these topics.
