ARTICLE 7 OFFICE OF TRUSTEE

General Comment

This article contains a series of default rules dealing with the office of trustee. Sections 701 and 702 address the process for getting a trustee into office, including the procedures for indicating an acceptance and whether bond will be required. Section 703 addresses cotrustees, permitting the cotrustees to act by majority action and specifying the extent to which one trustee may delegate to another. Sections 704 through 707 address changes in the office of trustee, specifying the circumstances when a vacancy must be filled, the procedure for resignation, the grounds for removal, and the process for appointing a successor. Sections 708 and 709 prescribe the standards for determining trustee compensation and reimbursement for expenses advanced.

Except for the court's authority to order bond, all of the provisions of this article are subject to modification in the terms of the trust. *See* Section 105.

ARTICLE 7 OFFICE OF TRUSTEE Colorado Comments

The Goal of the Colorado UTC Subcommittee is to conform to the uniform law as originally drafted when possible, and only make substantive changes when necessary to conform with Colorado law where appropriate and desirable or to provide clarity for the State of Colorado and its citizens.

- 701(a) (2) Language was added to avoid the interpretation that a prevision in the trust specifying a method to accept or decline trusteeship is not construed to be the only method to do so unless the document clearly states this requirement. This language is in response to the Colorado Appellate Court Case _______.
- 701 (c) (1) Adds language that a person designated as trustee my send a rejection of trusteeship to any other acting trustee. The committee concluded that in circumstances where co-trustees are appointed it would be appropriate to add notice of rejection of trusteeship to be sent to the co-trustee to the statute.
- 702 (c) Language was added to allow the settlor to specify in the terms of the trust whether the cost of a bond is charged to the trust to give additional weight to the directions of the settlor.
- 703 (g) (2) The language was changed by the Colorado Committee to allow a cotrustee to pursue a broad range of remedies to address a cotrustee's breach of duty. The committee was concerned that the UTC language would be interpreted to require a cotrustee to engage in litigation to address a cotrustee's breach of duty. The committee wanted to insure that less adversarial methods of resolution were considered appropriate.

- 704 (d) (2) The language was changed to provide adequate notice of the selection of a trustee to the Attorney General rather that requiring that the Attorney General concur with the selection. This language was added in response to difficulty in receiving notice of concurrence from the Attorney General's office.
- 705 (b) Language was added to insure that approval of the court is necessary for a resignation under the terms of this section and not for resignations under the terms of the trust instrument.
- 708 **Compensation of trustee.** The language was changed by the Colorado Committee to incorporate the existing Colorado Law which was enacted after extensive consideration and work by members of the Colorado Bar several years ago.
- 709 (b) The term reasonable was added to insure that the section allows only reasonable advances.
