#### **Colorado Law School Sees** Its Most Diverse Class Yet

In August, the University of Colorado Law School welcomed its newest class, comprising 179 JD, 17 MSL, and 12 LLM students. The Class of 2022 is the most diverse in Colorado Law's history: 33% of incoming JD students identify as people of color, over half (55%) are women, and 9% identify as LGBTO. This year's 1L class includes the third cohort of Colorado Law's Leaders in Law and Community (LILAC) Fellowship recipients. The program aims to address diversity in legal education by recruiting and developing students from backgrounds underrepresented in law schools and the legal profession.



The new student orientation took place from August 21-23 and included remarks by Dean Anaya, Professor Emeritus Charles Wilkinson, and Colorado Supreme Court Chief Justice Nathan Coats ('77).

#### Burg Simpson Supports Craig Hospital's Pedal 4 Possible

On September 15, a team of trial lawyers and legal professionals from Burg Simpson participated in this year's Pedal 4 Possible (P4P) charity bike ride. Riders started out in Louisville, and enjoyed beautiful scenery as they headed north along the Flatirons. The day finished at the post-ride party with beer, food, prizes, music, and fun. # Colorado Law Firms Raise over \$250,000 for JAMLAC
