Boulder County Legal Services (BCLS) celebrated the outstanding tradition of pro bono service in Boulder County at its Annual Pro Bono Luncheon, held April 30 at the Boulder Marriott. BCLS honored local attorneys, mediators, law students, and paralegals who volunteered 4,032 hours in 2017 to provide legal services to low-income residents of Boulder County.

The Boulder County Bar Association (BCBA) honored Judson Hite with the John Robert Marshall Award for his dedication in providing legal services to the poor. BCBA President Renée Ezer presented the award, which is bestowed annually in honor of John Robert Marshall, a local attorney who tirelessly advocated for the poor. Colorado Trial Lawyers Association Annual Spring Dinner

The Colorado Trial Lawyers Association (CTLA) hosted its 21st Annual Spring Dinner on May 10 at the Hilton Denver City Center. During the dinner, CTLA honored Christina Habas of Keating Wagner Polidori Free, P.C. with the Kenneth Norman Kripke Lifetime Achievement Award. Habas, a former Denver District Court judge, focuses her practice on products liability, serious personal injury, and wrongful death cases. Over the course of her career, she has tried more than 100 trials as an attorney and presided over more than 200 trials in her time on the bench. As a CTLA member, she has been an incredible asset to the association by sharing her time and talents.

The association also recognized Sarah Parady of Lowrey Parady, LLC with the New Trial Lawyer of the Year Award; Bachus & Schanker, LLC with the Outstanding Service to CTLA Award; Gary Blum, Steven Kelly, and the plaintiffs' attorney team in Cook, et al. v. Rockwell International Corp., et al. (Rocky Flats) with the Access to Justice Award; and Jonathan Harris, president of Build Our Homes Right, with the Consumer Protection Award.

In addition, the prestigious Case of the Year Award, which acknowledges the positive impact that a single case can have on correcting injustices, advancing fairness under the law, changing attitudes, or providing economic incentives to protect public safety, was presented to Paul Maxon, Sarah Parady, and Amy Trenary for their work on Hayes v. SkyWest Airlines. In Hayes, a jury ruled against SkyWest for discrimination, retaliation, and failure to accommodate, as well as retaliation in violation of the FMLA, sending a powerful deterrent signal to other would-be violators of a disabled person's civil rights.

Cybersecurity CLE Conference





In April, CBA-CLE hosted a cybersecurity conference led by Justice Daniel Crothers of the North Dakota Supreme Court and attorney Mark Lanterman with ComputerForensic Services in Minnesota.

One of the sessions took a dive into the dark web that enlightened (and shocked) the audience: Lanterman, who was a

sworn law enforcement investigator with both state and federal law enforcement agencies, including the U.S. Secret Service Electronic Crimes Task Force, provided a live demonstration of the dark web. During his presentation, he showed attendees the website of a credit card fraud ring. With thousands of options, buyers can choose the type of card (VISA, Mastercard, etc.), card country of origin, and the bank that issues the card. There is even a money-back guarantee if the stolen card doesn't work.

Showing how easy it is to purchase stolen credit cards led to a thorough discussion on the responsibilities that attorneys have when it comes to cloud computing, email, social media, and database management.

Another session examined electronically stored information (ESI) through the lens of the civil discovery rules. Topics included metadata, timelines, and the discovery and admission of ESI.

Despite the number of risks involved with client information, the speakers were able to share the steps and provide guidelines to minimize risk for attorneys and their clients.
