She started working with Dave Johnson in 2015 and partnered with him in April 2017 to form Johnson Kush P.C, a family law firm that provides significant pro bono representation. Across her



years of disparate experience, Joi reports that she particularly enjoys the challenge of appearing in court to advocate for her clients.
