#### 2. Officer's Reports:

## <u>Chair (Laura A covers for Robin Beattie)</u>:

- a) Judge Arp Supreme Court Standing Committee on Family Issues Judge Arp will be at our meeting in November. Asked EC to submit goals to discuss this meeting.
  - Robin has received some feedback;
  - Chris Radeff proposal provided in September and attached again (attymentors for new judges); consensus from EC that this is good idea to present to Judge Arp;
  - Joe Pickard proposal provided in materials; due process issues with status conference hearings, no notice, no conferral, etc.; escapes review; consensus from EC to present this issue; Bonnie discusses discovery master idea along with these issues;
  - Being forced to set hearings too quickly and not being given adequate time;

## <u>Chair Elect (Laura Ammarell)</u>:

a) Family Law Institute 2019 – August 15-17; planning committee of Danae, Laura P., Marie, Meredith Cord; co-chair is Barbara Jensen; call for proposals went out this week and already starting to receive proposals; consideration of changing the dates—troublesome for folks because of school start, kid college, vacations, etc.; fall in Vail is beautiful and being considered.
